o **Presentations**

Mary Jo Gleaves, VP of Regional Operations at The J. Morey Company, Inc., presented a summary of the Betsuin insurance coverage. Mary Jo handed out a written summary and answered questions from the Board members.

Al Hironaga, on behalf of the Sangha Support Committee, presented a powerpoint presentation of the need to upgrade existing or buy new video projector and screen for the annex. Al brought forth possible options. The Board requested Al and the Sangha Support Committee research an additional option prior to making a decision.

o **Motions**

It was moved/seconded/passed to accept the February 02, 2012 Board of Directors' Meeting as corrected.

It was moved/seconded/passed to pay for Dr. Kenji Akahoshi's registration fees (\$202.50) for the March 22 – 25, 2012 Buddhist Churches of America (BCA) Center for Buddhist Education (CBE) Ministers' Assistant Program Tokudo Training. The funds will come from the Education budget.

It was moved/seconded/passed to earmark the offerings collected at the March 25, 2012 One Year Memorial Services for the Japan Tsunami/Earthquake victims.

o **Ministers' Report**

Hanamatsuri is scheduled for April 08, 2012 in the annex. There will be one combined service. Dharma School and DSPO should plan the program and lunch accordingly. Jr YBA should note that there is a need for only one hanamido this year.

One Year Memorial Services for the victims of the Japan Tsunami/Earthquake victims will be held on March 25, 2012. All offerings collected that day will be earmarked for the disaster relief effort.

o **2012 Priority Setting Committees**

Infrastructure Committee

The Committee met with Russell Imoto who was involved in building the Fresno Betsuin Dharma Center. The committee continues to study options and is obtaining estimates for various options. The Committee's goal is to present a recommendation at the April Board meeting.

## Membership Committee

The Membership Committee has begun a dialogue with the Betsuin Office Staff to learn what the process is when one applies for membership to the temple. The Committee will be obtaining Dharma School application information regarding membership status.

The Committee welcomes the implementation of PayPal as a vehicle for pledges and donations.

The Next BCA Bishop

The BCA National Council Meeting (NCM) delegates ratified the election of Rev Kodo Umezu as the next BCA Bishop.

In his capacity as BCA Bishop, Rev Umezu is assigning Rev Marvin Harada to work 1/3 of his time as the Assistant to the Bishop and 1/3 of his time as Co-Director for CBE and will continue his work at Orange County Buddhist Temple (OCBC) and Vista Temple. Rev Kiyonobu Kuwahara will work 2/3 of his time as Co-Director of the CBE and will be on-site at the Jodo Shinshu Center (JSC). Rev Michael Endo will remain as Secretary to the Bishop and he will continue with the responsibilities that he currently has. It was noted that the "team approach" of Rev Harada and Rev Kuwahara should result in a budgetary savings to BCA.

Jodo Shinshu Center Debt Relief Project

This project began on May 31, 2011 and will end on May 31, 2012. As of February 17, 2012, \$784K was collected. With donations received through this project, BCA was able to make two \$500K payments for the bank loan making our monthly bank loan payments approximately \$13,000/month. If BCA can collect additional donations by May 31, 2012, one more \$500K payment may be made which would reduce the monthly loan payments to approximately \$10K/month.

During the NCM, the Canada Kyodan donated \$6,500 and the Hawaii Kyodan donated \$5,000 to the JSC Debt Relief Project.

#### Dharma Offering/Annual Giving Program

A new BCA donation approach was presented and approved. Detailed information is forthcoming from the BCA Executive Board.

#### BCA Budget for FY 2012 – 2013

The BCA Budget for FY 2012 – 2013 is \$2,656,950.47.

A motion was passed to set the 2012 - 2013 membership assessment at \$99.99 per member.

#### Accession Service and Ceremony

The service and ceremony for Reverend Kodo Umezu will be on June 02, 2012 from 4:00 pm at the Buddhist Church of San Francisco Hondo.

#### Congratulation and Testimonial Dinner
